

The Lancaster Community offers scholarships for children that will be ages 5-14 in the Fall of 2016. The purpose of the scholarship is to fund a portion of enrollment for Summer Recreation programs. Scholarship consideration is primarily based upon need. Please refer to the Eligibility Requirements for additional information.

Individual scholarships will be awarded for a maximum of \$75. Applications are due April 1st. However applications will be processed after this date on a first come basis if funds are still available. Please refer to City of Lancaster 2016 Pool and Summer Recreation Activity Guide for options.

Eligibility Requirements

1. Youth and their families must reside in Grant County.
2. Our program is designed for children that will be ages 5-14 in the Fall of 2016.
3. Students and their families must qualify as low/moderate based income based upon chart below.

Which Summer Recreation Programs are eligible for the scholarship program?

All summer recreation programs in the City of Lancaster 2016 Pool and Summer Recreation Activity Guide are eligible for scholarships.

When are applications due?

Applications are due by April 1, 2016. Applications received after that date will be processed on a first come basis if funds are still available.

How many scholarships can my child receive?

Each Scholarship is awarded for a maximum of \$75. Each child may receive a total of two scholarships per year.

When will I find out if my child received a scholarship?

You will be notified by mail within two weeks.

Will I get a check for the scholarship award?

No. The committee send a check to the City. You will receive a letter indicating the amount of scholarship. You will be required to pay any remaining balance to the Sponsoring agency.
