

The Lancaster Community offers fee assistance for children that will be ages 5-14 in the Fall of 2020. The purpose of the fee assistance is to fund a portion of enrollment for Summer Recreation programs. The consideration is primarily based upon need. Please refer to the eligibility requirements for additional information.

The individual fee assistance will be awarded for a maximum of \$75. Applications will be on a first come first serve basis if funds are still available.

Please refer to City of Lancaster 2020 Pool and Summer Recreation Activity Guide for options.

**Eligibility Requirements:**

1. Youth and their families must reside in Grant County.
2. Our program is designed for children that will be ages 5-14 in the Fall of 2020.
3. Students and their families must qualify as low/moderate based income base upon chart below.

**How many fee assistances can my child receive?**

Each fee assistance is awarded for a maximum of \$75.

**When will I find out if my child received assistance help?**

You will be notified by phone and letter within two weeks.

**Will I get a check for the fee assistance award?**

No. You will receive a call and letter indicating the amount of the fee assistance. You will be required to pay the remaining balance.
